

CHAPTER 8

THE OUTLOOK FOR 1975-76

8.1 Forecasting the rate of growth of an economy in which agriculture accounts for nearly one-half of national income is always a risky venture. In any such evaluation, one has to take note of the continuing operation of a number of domestic constraints as well as the increased uncertainty of the international trading environment which may act as inhibiting factors in any marked step-up in the rate of growth of national income during 1975-76. Nevertheless, the available information in respect of some important sectors of the economy points to an improvement in the overall performance of the economy in the coming year even though no dramatic changes can be expected in the short run.

8.2 Reference has been made earlier in this *Survey* to the limited impact of the Green Revolution on agricultural production, as also to a certain deterioration in the quality of seeds which has affected the production of wheat since 1971-72. Nevertheless, considering the fact that since 1970-71 the irrigation potential has increased by nearly 3 to 4 million hectares and that the high-yielding varieties now cover a much larger area, it should be possible to sustain a higher growth rate in agricultural output in the years to come. Uncertainty regarding the availability of fertilisers and a steep increase in their prices since May 1974, however, complicate the picture and make it difficult to form a definite judgement about the likely growth of agricultural production in the coming years. It is, of course, obvious that a substantial increase in the rate of growth of food production is greatly dependent on the achievement of a breakthrough in the productivity of rice and coarse grains. Among commercial crops, only raw cotton offers some promise in the short run, even though the expectations aroused earlier by the discovery of new varieties such as MCU-5 and Hybrid-4 have had to be modified considerably since then.

8.3 As for industrial production, the power supply is expected to maintain a rate of growth of about 10 per cent in 1975-76, assuming normal rainfall. The production of coal and steel can also be expected to show an upward trend. These factors should provide a significant stimulus to increased production in industry, provided that the transport bottleneck ceases to be as important a constraint as was the case in the past. However, the international trading environment has become more unfavourable and this may well affect exports of some of our industrial products. Greater utilisation of industrial capacity would facilitate a significant increase in industrial output. Yet it has to be recognised that fuller utilisation of capacity in capital goods and intermediate products is linked in an important manner to the progress of

public sector investment. If the stringency of financial resources stands in the way of a significant step-up of investment in the public sector, this will affect capacity utilisation. Moreover, one has to take note of the inevitable fluctuations in the production of important industrial raw materials of agricultural origin. Nevertheless, on current expectations, the overall rate of growth of industrial production in 1975-76 is likely to be higher than in 1974-75.

8.4 In the short run, we have only a limited margin of manoeuvrability in bringing about a sharp acceleration in the overall rate of growth. Nevertheless, economic policy planners must grapple in 1975-76 with the task of raising the rate of growth of national income in years to come beyond the trend rate of 3 to 3.5 per cent which seems to have become the unenviable lot of the economy in the last fifteen years. This is by no means going to be an easy task since inflationary tendencies in the economy are still very strong and any expansionist policy will have to be so devised as not to accentuate the existing pressures in the economy. A premature general reflation of demand will give a fresh lease of life to inflationary expectations, and in that event, prices may tend to rise even faster than in the last two years. It is, therefore, imperative that the needed stimulus to the economy must be planned in the context of continued overall emphasis on fiscal and monetary restraint.

8.5 Although there has recently been considerable talk of a recession, the available indicators point to a gradual increase in the industrial production in the coming months. Of course, the insistence of some segments of industry to maintain prices, in face of consumer resistance, at a level yielding abnormally high profit margins of the last two years, might lead to some temporary reduction in capacity utilisation in certain sectors. However, in all such cases, the emphasis must be on persuading industry to pursue more realistic pricing policies than for the Government to relax prematurely the fiscal and credit curbs. All the same, one cannot rule out the possibility that the current state of business psychology, coupled with uncertain prospects for some of our industrial exports, and the sluggishness in public sector investment may require some adjustment in current policies in the future. Both the timing and the extent of needed adjustments will be influenced by the trend of export demand as well as by the state of the domestic food economy. However, as of now, it appears that in the background of acute inflationary pressures in the last two years, our response to such a situation should be to sustain business confidence in investment and export markets through more selective stimuli rather than a general reflation of demand.

8.6 In recent years, Government have made impressive efforts to mobilise additional financial resources both by way of taxation and market borrowings. Unfortunately, a major proportion of the resources thus mobilised has been absorbed by the increase in non-developmental expenditure, particularly on pay and allowances. As a result, the public savings potential implicit in additional resource mobilisation efforts has not been realised. Since an increase in the saving rate is an essential condition for sustaining higher rates of investment, new strategies will have to be worked out to raise the rate of saving. On account of a steep increase in prices in the last two years, this is admittedly not going to be an easy task. Yet a fuller utilisation of the substantial excess capacity that now exists in the public sector alone would make a significant contribution to enlarging the pool of public sector savings. A more realistic pricing policy for public sector enterprises would also help to generate new savings. Similarly, adoption of more effective methods of tax administration designed to reduce tax evasion would not only help to raise public sector savings but also enhance the effectiveness of our tax system in reducing inequalities in income and wealth. Moreover, pursuit of flexible pricing policies for industrial products in general would not only help to reduce the hold of black money on our economy but would also improve Government revenues and public savings.

8.7 There are also considerable opportunities for diverting more of available savings for higher priority investments both in the public sector and in the private sector. Currently, the bulk of national savings originate in the household sector but only one-half thereof takes the form of financial assets whose deployment is generally subject to social control. It is likely that the rapid inflation of the last two years may have reduced the attractiveness of savings in the form of financial assets such as bank deposits. It is necessary to forestall such a development through a policy-mix which is conducive to increased savings in the form of approved financial assets. Ways and means have also to be found to ensure that the available savings in the corporate sector are ploughed back into expansion in high priority industries rather than being diverted to projects which are very low on the list of national priorities.

8.8 In any viable strategy for raising the standard of living, one can hardly over-emphasise the importance of reducing the rate of population growth. The family planning programme has helped to create greater awareness of the population problem in the country. It has been estimated that currently about 15 per cent of couples of child bearing age practice family planning. The birth rate also shows a declining tendency. Nevertheless, overall progress has fallen considerably short of the initial expectations. It is, therefore, necessary to reorient our family planning programme so as to ensure that it gains the required momentum.

8.9 The steep increase in the price of petroleum since January, 1974 represents a major structural change in international economic relations. It is obvious

that in order to ensure continued viability of India's balance of payments in the years to come, we must not only reduce our dependence on imported sources of energy but also greatly intensify our export promotion efforts. As a result of higher oil prices, we shall have to think in terms of a minimum increase of 10 per cent per annum in the export volume. The rapid increase in the value of our exports in the past two years was mostly due to higher prices and in terms of volume, the export growth of about 4 per cent per annum observed since 1968-69 does not indicate any major breakthrough. In 1974-75, we had to draw heavily on the resources of the IMF to finance our payments gap. The IMF is expected to operate an expanded oil facility in 1975 and this should provide us with some more time for adjustment to the new realities. However, we must plan ahead for the days when there will be no oil facility in the IMF and we will be called upon to start repaying to the IMF our existing debts. In this context, the task of export promotion assumes very great importance. In the last fifteen years, India's economic structure has been greatly diversified. As such, we now have the capacity to achieve a major breakthrough in exports provided exporting, on balance, becomes as remunerative as, if not more attractive than, sales in the home market. The world trading environment in 1975 is not likely to be conducive to a major expansion of world trade. Nevertheless, since our share of world exports in manufactures is insignificant, given an active promotional policy, we should be in a position to raise our export earnings by a substantial amount.

8.10 As regards the agricultural sector, a significant increase beyond the observed trend rate of growth of about 3 per cent per annum will require a major reorientation and strengthening of our agricultural programmes. At the same time, we must not fall a prey to the romantic illusion that there are ready-made shortcuts to the modernisation of agriculture. In the short run, there are limits to an increase in the production of foodgrains. Moreover, one cannot lose sight of the inevitable fluctuations in output from year to year. As such, while adopting every possible measure to increase food production, the utmost emphasis must continue to be laid on strengthening the system of procurement and public distribution of foodgrains.

8.11 As will be obvious from the analysis contained in the earlier part of this Survey, there is an urgent need to revitalise the seed industry in the country. Arrangements for the production of breeder seeds need to be greatly expanded and for this purpose, it is necessary to have a fresh look at the resources which are being earmarked for agricultural research. There must also be an augmentation of the capacity of the National Seeds Corporation and the other public sector agencies to cope with the increasing demand for quality seeds.

8.12 It is equally essential to step-up the rate of expansion of net area under irrigation, from about 1 million hectares per annum in the past five years, to about 2 million hectares per annum in the coming

years. This would require that various major and medium irrigation works which are under construction or in advanced stages of planning should not be starved of funds on account of over-run of costs. It will be necessary to resolve the inter-State disputes over the distribution of river waters with greater speed and efficiency. A failure to settle these disputes involves a significant national loss of potential output which would have been made possible by a faster expansion of the area under irrigation. In addition, more effective arrangements will have to be made for the speedy exploitation of vast groundwater resources in Eastern and North Eastern India.

8.13 No less important is the task of making full use of the existing irrigation potential. The Command Area Development Programme contemplated in the draft Fifth Five Year Plan can make a significant contribution to increasing agricultural output, provided the administrative structure has the necessary degree of flexibility and adaptability. The programme has been slow in getting organised. It is necessary to impart a greater degree of momentum to this programme so as to ensure that practical answers to various organisational and technical problems are speedily found.

8.14 At a time when we spend large amounts of money on imported fertilisers, it is distressing to find that a sizeable proportion of domestic capacity goes unutilised. Inadequate supply of power has contributed to this state of affairs. Nevertheless, there is evidence to suggest that power cuts cannot be an adequate explanation for our failure to make full use of available capacity. There have been visible gaps in the operation of a number of fertiliser units. Considering the heavy social costs of idle capacity in this crucial area, these gaps must be filled in with utmost speed. New fertiliser schemes which are now contemplated will also have to be speedily implemented. Any delay in their completion will have a serious adverse effect on our ability to increase fertiliser consumption by the end of the Fifth Plan to about 7 million tonnes.

8.15 To sum up, India's economy in 1975-76 will have to reckon with a highly uncertain international environment. Nevertheless, the overall outlook will be greatly influenced by the trend of agricultural output. The resumption of an orderly process of growth with stability is, therefore, crucially dependent on our ability to impart a new element of dynamism to Indian agriculture.
