5 RCTC was established in January 1988 on reconstitution of Risk Capital Foundation set up by IFCI in 1975 and data of RCTC upto 1985-86 are on calendar year basis, and thereafter on April-March basis.

6 The name of IFCI has been changed to IFCI Ltd. with effect from July 1, 1993.
