- 1. This includes provision for the establishment and other expenditure of the Customs wing and for payment of proportionate charges to the Central Excise wing for customs work done by it at minor ports and land customs border posts.
- Provision is for expenditure of the Coast Guard Organisation, which ensures the security of the maritime zones of India.
- 3. This includes provision for payment to other Departments etc. besides Rs.10 crores for Customs Welfare Fund.
- 4. The provision is for establishment expenses of the Central Excise Organisation including other expenses on collection of Union Excise Duties. The Central Excise wing also performs customs work at certain places like minor ports and land customs stations for which proportionate charges are recovered from the Customs wing.

- 5. Provision represents cost of printing of match excise banderols and Union excise stamps and labels.
- 6. This includes provision mainly for the establishment and other expenditure on Inspection, Statistics and Intelligence, Training, Vigilance, Directorate of Publicity & Public Relations and Directorate of Anti-evasion. This also includes a provision of Rs. 138 crore in BE 2001-02 for interest on refunds of excess tax. Hitherto the interest was being included in the refund of taxes and netted from gross tax revenue.
- 7. This includes a provision of Rs.6 crores for purchase of ready built office buildings and Rs.34 crores for purchase of ready built residential buildings in respect of Customs and Central Excise Departments.
