MEMORANDUM SHOWING THE PROPOSED REVISION OF POSTAL TARIFFS 2001 (VIDE CLAUSE NO. 131) OF THE FINANCE BILL, 2001.

The maxima of the tariffs leviable for certain postal articles are prescribed by the First Schdule in the Indian Post Office Act, 1898. Within the maxima so prescribed in respect of such articles in respect of other postal articles not included in the Schedule and other services, the Central Government have the power to fix the rates by notification in the OfficialGazette by amending Indian Post Office Rules, 1933 (vide Section 7 of the Indian Post Office Act, 1898.)

2. The proposals for revision of tariffs listed in the following table relating to postal articles at serial Nos. 1 to 7 require an amendment to the First Schedule of the Indian Post Office Act, 1898 and these have been included in the Finance Bill. These changes as also the revision of tariff for other postal services would be made amending Indian Post Office Rules, 1933
