1. The provision is for expenditure on Defence Secretariat (DOD, DP&S, DR&D, DESW and Finance Division) and Defence Accounts Department.

2. The provision is for expenditure of the Defence Estates Organisation, whose main functions are administration of Cantonment Boards, management of Defence lands both inside & outside the Cantonments, requisition and hiring of immovable properties for Defence purposes, etc.

3. The provision is for expenditure of Coast Guard Organisation, which also includes provision for acquisition of Ships, Fleets, Air Crafts & Major works.

4. The provision is for Jammu & Kashmir Light Infantry (JAKLI) which was known as J&K militia upto May 1977 and presently a full fledged Regiment of Indian Army having 15 Battalions apart from a Regimental Centre and Record Office. It's budget which was being shown under Ministry of Home Affairs so far has been shifted to Ministry of Defence budget w.e.f. BE 2005-06.

5. Canteen Stores Department is a departmental commercial undertaking of the Ministry. It is functioning with the object of providing household articles and other items of daily necessity to members of the Defence Services at reasonable and economical rates throughout India. The provision under this head

is for net working expenses (the receipts exceeding the gross expenditure).

6, 7,8 & 9. The provision is for residential housing facilities to the staff of the Canteen Stores Department, Defence Accounts Department and Defence Estates Organisation. The provision in the budget for 2005-2006 is based on the tempo of work and on account of decentralisation of existing procedure for purchase of ready-built residential & non-residential building in respect of Defence Accounts Department and maintenance thereof.

10. The provision is for repairs and maintenance expenditure of Defence Accounts Department's Office/ residential buildings and construction of office buildings for the Defence Accounts Department and Defence Estates Organisation (DEO).

11. The provision is towards interest subsidy given to Defence Public Sector Undertakings (PSUs) on the loans raised by these undertakings for implementation of voluntary retirement scheme.

12. Other Expenditure: Covers mainly certain items relating to the Ministry such as Establishment of Chief Directorate of Purchase under Army Purchase Organisation and loans for Unit Run Canteens of Canteen Stores Department, etc.
