

SCHEMES FOR DEVELOPMENT OF SCHEDULED CASTES AND SCHEDULED TRIBES**STATEMENT 20**

Government is committed to the welfare of Scheduled Castes and Scheduled Tribes and in particular, ensuring full equality of opportunity in education and employment. A maiden effort has been made to present at one place the budget provisions that are substantially meant for the welfare of Scheduled Castes and Scheduled Tribes. This class of beneficiaries also benefits from other programmes but that is not presently segregated/quantified. This is intended to serve as a reference point for future exercises to segregate budget provisions according to the classes of beneficiaries as mentioned in the Statement No. 19 regarding budget provisions meant substantially for the benefit of women and children. The Budget allocations, net of recoveries, substantially for the benefit of Scheduled castes and Scheduled Tribes are as follows :
