1. The provision is for expenditure on Secretariat of the Ministry of Urban Employment and Poverty Alleviation.

2. Government of India provides assistance to the States and Union Territories for implementation of sanitation programmes through a Centrally Sponsored Scheme called Low Cost Sanitation Programme for Liberation of Scavengers.

3. The provision is for National Buildings Organisation which is engaged in establishing an efficient Management Information System and data bank on housing etc.

4. The provision includes contribution to Central Government Employees Welfare Housing Organisation, assistance to Building Materials and Technology Promotion Council, contribution to NCHF, annual membership fee to the Commonwealth Local Government Forum and for organising an Inter-ministrial Conference of Asia-Pacific Region dealing with UN-HABITAT. 6. The provision is for UNDP assisted programme "National Strategy for Urban Poor" .

7. This provision is for the scheme of Swarna Jayanti Shahari Rozgar Yojana (SJSRY) aimed at providing gainful employment to the urban unemployed or underemployed poor.

8. This provision is for the Centrally Sponsored Scheme namely Valmiki Ambedkar Awas Yojana, which provides for construction and upgradation of shelter for Urban Slum Dwellers below poverty line with focus on vulnerable sections of the society such as SC/ST, OBC etc.

10. This provision is for loan assistance to Hindustan Prefab Ltd.

11. The provision is for projects/schemes for the benefit of the North Eastern Region and Sikkim.
