This Demand includes provision for grants payable to States under Article 275(1) of the Constitution on the basis of the recommendations of the Twelfth Finance Commission, Block Grants for State Plan Schemes, short term Ways and Means Advances to States and assistance from National Calamity Contingency Fund (NCCF).

The National Old Age Pension Scheme (NOAPS) under NSAP was renamed as the Indira Gandhi National Old Age Pension Scheme which came into effect from 19.11.2007. The eligibility criteria under the new scheme has been revised to include all persons of the age of 65 years or higher and belonging to a household Below Poverty Line. With the revision in the eligibility criteria, the number of beneficiaries under NOPAS would increase from 165 lakh to 246.35 lakh.

The scheme of Nutrition Programme for Adolescent Girls (NPAG) was approved in 2003-04. Scheme of National E-Governance Action Plan (NEGAP) was approved in 2004-05.

Provision has also been made for providing grants-in aid as assistance for Development of Golden Temple. Provision has also been made for providing ACA for Externally Aided Projects (EAPs) to the States including loans.

Provision for the Schemes for Sub-Mission on Urban Infrastructure & Governance, Urban Infrastructure Development for Small and Medium Towns (UIDSSMT), Sub-Mission on Basic Services to Urban Poor, Integrated Housing & Slum Development (IHSDP) under the scheme Jawahar Lal Nehru National Urban Renewal Mission (JNNURM) and Tsunami Rehabilitation Programme (TRP) have been made.

The provision has been made for Brihan Mumbai Storm Water Drain Project (BRIMSTOWA), Mumbai and Desalination Plant at Chennai.

Provisions included in this Grant also represent transfer of resources by the Ministry of Finance to the States and Grant in lieu of share in Central Taxes & Duties to NCT of Delhi.
